3. Purchase and sale of digital assets for cash and/or funds in the account and/or electronic money

<p>3.1. Purchase of digital assets using funds in the account and/or electronic money</p>	<p>Due to the specific nature of operations and the high volatility of digital asset prices on the Over-the-Counter (OTC) market, Vescon d.o.o. does not charge a percentage-based commission for the purchase of digital assets using funds in the account and/or electronic money.</p> <p>Instead, the purchase process functions as follows: The user submits a request to purchase digital assets using funds in the account and/or electronic money. Vescon d.o.o. provides an offer consisting of the quantity of digital assets that can be purchased for the amount specified by the user, as well as the exchange rate at which the purchase can be executed.</p> <p>If the user approves the offered quantity and exchange rate, the purchase is executed.</p>
<p>3.2. Sale of digital assets using funds in the account and/or electronic money</p>	<p>Due to the specific nature of operations and the high volatility of digital asset prices on the Over-the-Counter (OTC) market, Vescon d.o.o. does not charge a percentage-based commission for the sale of digital assets using funds in the account and/or electronic money.</p> <p>Instead, the sale process functions as follows: The user submits a request to sell digital assets using funds in the account and/or electronic money. Vescon d.o.o. then provides an offer consisting of the exchange rate and the price it is willing to pay for the digital assets.</p> <p>If the user approves the offered price and exchange rate, the sale is executed.</p>
<p>3.3. Transfer of funds to the Company's bank account (deposit)</p>	<p>Free of charge</p>
<p>3.4. Transfer of funds to the user's bank account (withdrawal)</p>	<p>0.1% of the amount, minimum RSD 33.00</p>
<p>3.5. Transfer of digital assets to the Company's digital wallet (deposit)</p>	<p>Free of charge</p>
<p>3.6. Transfer of digital assets to the user's digital wallet (withdrawal)</p>	<p>0.1% of the value of digital assets + Gas Fee</p>

#### 4. Exchange of digital assets for other digital assets<sup>3</sup>

4.1. Exchange of digital assets for other digital assets	<p>Due to the specific nature of operations and the high volatility of digital asset values on the Over-the-Counter (OTC) market, Vescon d.o.o. does not charge a percentage-based commission for the service of exchanging digital assets for other digital assets.</p> <p>Instead, the process functions as follows: The user submits a request to exchange one type of digital asset for another. Vescon d.o.o. then provides an offer containing the exchange rate at which it is willing to execute the exchange. If the user approves the offered rate, the transaction is executed.</p>
4.2. Transfer of digital assets to the Company's digital wallet (deposit)	Free of charge
4.3. Transfer of digital assets to the user's digital wallet (withdrawal)	0.1% of the value of digital assets + Gas Fee

<p>6.1. Digital asset portfolio management in accordance with the agreed strategy</p>	<p>The fee consists of two components:</p> <ol style="list-style-type: none"><li>1. 2% annually of the total portfolio value. Charged proportionally on the first day of each month for the previous month, based on the average portfolio value during that month;</li><li>2. 25% annually of the increase in the dinar value of the portfolio (i.e. profit). Charged on the first day of January, or proportionally.</li></ol>
